## SPEAKER/PROGRAM

 Chief Hill introduced Ken Dennings who introduced guest speakers from SICON who presented their scientific/ecologically safe approach to reducing the Swimmer's Itch problem in Higgins Lake. Their program would run from 4/15/15 – 7/31/15 with a biology lab and research boat and is based on trapping the Common Merganser duck nests and eggs and relocating them to either Lake Huron or Lake Michigan and clipping their wings. (These lakes do not house the snail species that cause Swimmer's Itch.) They would also study and test the large populations of the two species of snails that cause the disease and remove as many as they can. Swimmer's Itch can never be eradicated; however it can be greatly reduced by this 3-year program.

• Supervisor Frank Homola from the local Swimmer's Itch Task Force introduced guest speakers from the DNR Fish & Wildlife Services who explained their harassment and lethal take method via a Gerrish Twp. permit which will be done by 5/22/15. This process involves harassing the migrant Common Mergansers to keep them moving to other areas, setting up nesting boxes so those that take up residency can be tracked and their eggs oiled so that they do not hatch with a final lethal take on 25 birds, targeting the hens. Would also include snail studies on the two species of snails that are hosts to the organisms that cause the disease, check infection rates and do organism counts on entire lake and remove areas of large algae nutrients caused from phosphates (fertilizers) that the snails feed upon. Home owners in the water shed areas of Higgins Lake should try to be wary of what type of fertilizers they are using on lawns (low or no phosphates) and keeping septic tanks and fields properly pumped and maintained to help eliminate excess ground run off that goes into the lake and causes nutrient food sources for these snails. Swimmer's Itch is a 2host disease that cycles between the Common Mergansers and the two specific snail species.
