## **OLD BUSINESS**

- Austin gave an update on the golf outing including going over the volunteer sign-up sheet. There are 14 pre-registered teams at this time, possibly 4-6 more teams may show up on day of event. There are currently 17 hole sponsors that have paid, along with Nester's who provided hole-in-one and signs for the car and other prizes. Several donations for prizes have been received, special thanks to John Klein and Carmine Polisei for working on prizes. 10 cases of pop have been picked up from Pepsi West Branch and all arrangements have been shored up at golf course including food. Officers have gone out and solicited golf packages for prizes and Austin has purchased the Chinese Raffle items.
- Valentine Dinner Dance state license has been received and ticket proof has also just been received. After review of the ticket proof, the tickets will be printed with an estimated completion date of mid-August. Will invite Brandon Rodgers to next ACT NOW Executive Board meeting in September for a project update including proposed project budget.

#### **CERT UPDATE**

- Region 7 will be disbursing \$1,000 to our CERT team from reimbursement grants once we submit a list of specific equipment/items to them. We will be requesting items to stock the new CERT trailer. Sharon and Brian will be meeting to go over that list.
- Sharon also received more equipment from the Region including 10 wands/cones lights, vests, pocket masks, CERT patches, a power inverter and a scene light.
