### GERRISH TWP. FIREWORKS ORDINANCE NO. XXXIII

With summer upon us and the approach of Independence Day, we would just like to remind everyone about Fireworks use Gerrish Township. The purpose of this ordinance is to establish a safe environment for the use/discharge of fireworks regulate the public and to general health, safety and of welfare persons and property.

#### **DEFINITIONS:**

Fireworks" "Consumer are devices that are designed to produce visible effects by combustion and leave ground such as aerials, Roman candles, bottle rockets. helicopter firecrackers. spinners, re-loadable shell devices devices, missile-type and single tube devices.

"Low Impact Fireworks" are ground-based and some hand held sparkling devices.

No person shall ignite, discharge or use fireworks or Chinese Lanterns within the Township of Gerrish at any time, except:

1)In compliance with any permit issued by the Township in accordance with the Act and this Ordinance.

2)Consumer Fireworks are permitted the day before, the day of, and the day after a Federal Holiday.

3)Low Impact fireworks are permitted all year-round.

WHEN USING CONSUMER FIREWORKS IN ONE OF THE ALLOWABLE USES ABOVE, THE PERSON IGNITING THE FIREWORKS SHALL FOLLOW NATIONAL FIRE PROTECTION ASSOCIATION CODE 1123.

## USE OF CONSUMER FIREWORKS ON JULY 3RD, 4TH & 5TH

Consumer Fireworks shall not be ignited, discharged, or used from any location without the owner's written permission. They cannot be used on public property, including streets and rights-of-way, on any school or church property or from the property of another person.

Consumer fireworks shall not be

Consumer fireworks shall not be used by a person under the influence of alcohol, a controlled substance or a combination of both.

Any person using Consumer

fireworks shall be responsible for all shells or devices and clean up of debris including securing areas of unexploded shells until they are found. This Ordinance is enforced by Gerrish Twp. Police and any violation is a misdemeanor punishable upon conviction by a fine not exceeding \$500, imprisonment for not more than 90 days, or both.

#### **South State Park Youth Alcohol Enforcement**

The Gerrish Township Police Officers along with Gerrish Twp.
